Dear Mr. Frank:-

I have your letter of Saturday, July 3rd, and I am surely glad to hear that you are rapidly regaining your health.

Upon my return to Chicago, I found a considerable number of petitions - some of which I mailed to Mr. Alexander, and those received later to your dear wife. At the time, I wrote Mr. Alexander, that he be kind enough to send me a copy of Conley's letters written while incarcerated in jail, showing their similarity with the murder notes, and the photographs explaining your theory how Mary Phagan was murdered. Mr. Alexander then informed me that the copies were with the Prison Commission, and as soon as he could secure one of these copies he would forward it to me. I wanted to use this with the other information that you gave me, but up to date have not received same. I would appreciate the kindness of having you get it for me, as I may be in a position to make use of it to your benefit.

It was very difficult to get space in our papers on account of the war scare and the columns being full of German and Wilson notes, followed by the Bryan resignation. Chicago then was threatened with a car strike and this kept our papers busy. However, considerable space was given to what our committee did, which I will gather and send to you. Any other article that I find touching upon your case which you probably have not read, I will secure for you.

Our opinion of Governor Slaton was fully confirmed when we heard of his commuting your sentence. He told us that he would study the record and would act as he saw the truth, and would not shirk his duty. He surely is the biggest man in Georgia today, and the state will recognize that fact sooner or later. For his courage, he has gained the admiration of the entire country. I am sure that the time is not far distant when your complete innocence will be acknowledged, and that you will be fully pardoned.
